The Governors of Dean Barwick School are proposing to make a prescribed alteration to the school by extending the age range from 4-11 to 3-11 to allow the provision of nursery education.

School capacity

The objective of the proposal is to provide nursery education for up to 8 part time pupils aged 3 and 4.

The consultation process was carried out by the County Council on behalf of the Governors of Dean Barwick School in line with the guidance issued by the Department for Children Schools and Families. As well as the distribution referred to above you can see from the distribution list that copies were made available in public places and also on the County Council website. No formal meetings were undertaken as part of the consultation process.

Project costs

Any minor alterations to the existing school buildings will be met from the school's devolved formula capital.

The Governors are currently in the process of adapting and extending the school. As well as creating more office space there is also a new space that will be used for teaching. These alterations are likely to have the effect of increasing the net capacity of the school. Currently the school has a Key Stage 1 class taught in the classroom and the Key Stage 2 class taught in the classroom/hall. As the hall is regarded as such in the DCSF formula for assessing the capacity of the school it does not show in the existing net capacity of 28. The implementation of the proposal is not dependant on this building project, which is currently underway, as it can be implemented within the existing school accommodation.

It is anticipated that the proposed nursery class would initially operate each morning (Monday to Friday) during term time. Each session would usually last for three hours. Parents will be allowed to access, free of charge, up to 15 hours each week (5 three hour sessions).
