

**Commons Act 2006 - Section 19 2(a)  
Notice of application to correct the register**

Notice is hereby given that an application has been made by **Mark Dunn** ("the Applicant") to Cumbria County Council as Commons Registration Authority, under Section 19 paragraph 2(a) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to register units CL85 Bampton Common and CL87 Askham Fell.

A summary of the effect of the application is as follows: Application number 1373 was made on 23 December 1969 and resulted in the registration of a right of common, exercisable over two commons, registered at entry 68 of register unit CL85, and entry 12 of CL87. The particulars of the land to which the rights are attached is listed in column 5 of the registers as "Land at Beckfoot, Bampton, comprising O.S. plots numbered 356, 358, 359, 359a and 364 of the parish of Askham and O.S.plots numbered 95, 96, 99, 101, 102, 102a, 117, 671, 672 and part O.S. plots numbered 97, 100 and 670 of the parish of Bampton." ("the Dominant Tenement")

The Applicant claims that application 1340 made on 6 October 2009 claimed, amongst other rights, all of the rights associated with the part O.S. 670 listed under the Dominant Tenement. However, when processing the application the Registration Authority proceeded as if the whole of O.S. 670 was included in the Dominant Tenement. This resulted in the portion of O.S.670, to which there is no rights attached, being recorded at entry 86 of CL85 and entry 17 of CL87, and subsequently transferred to entry 98 of CL85 and entry 20 of CL87. The Applicant seeks by this application to correct the said mistake.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by deleting the current entries where the reference to part O.S. 670 should not apply, and creating new entries without O.S. 670 listed.


