### FREEDOM OF INFORMATION ACT 2000 - DISCLOSURE

The council has completed its search relating to your request for information about troubled families, which we received on 06 May 2014.

The council holds information within the definition of your request.

#### **Question 1**

What was the cost to the public purse of the most expensive Troubled Family in the most recent year for which you have data?

### Answer 1

Unfortunately we do not currently have the ability to accurately monitor the fiscal case with each "Troubled Family". The national Troubled Families team are working on a cost benefit analysis tool, which some local authorities have piloted. Once this is disseminated we will be in a better position to answer this request

#### Question 2

Please state how many interventions were made to assist this family and how many different services made those interventions in that year?

## **Answer 2**

In Cumbria, the Troubled Family work goes under the name "Focus Family". As previously explained, we cannot pin point an exact family in need of services and, therefore, we cannot breakdown exactly which services they used. However, our ethos is not to minimise the support a family needs by reducing the number of services, but rather we aim to maximise the impact of each service through co-ordination and provision of holistic support. A good quality piece of work can mean that initially more services are used to address a family's needs but we would expect this to reduce as the family move toward universal provision. So far, this seems to be the pattern of our families.

## **Question 3**

Please state how many Troubled Families you have in your area, and their total cost to the public purse in the most recent year for which you have data? [Where possible, this covers data local authority housing, anti-social behaviour and children's services, the health system].

## **Answer 3**

In Cumbria we have identified 1060 Troubled Families. This is above our national target. Again, at the moment we are unable to provide a financial breakdown of the costs associated with these families. However, the document "The Cost of Troubled Families" provides some indication of possible costs. Comparable authorities with rural locations such as West Cheshire and Cornwall have estimated that one family can cost between £47,000 and £93,000 a year.
