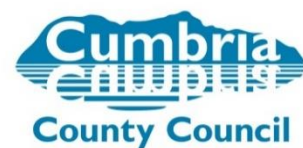

1 Introduction

The purpose of this document is to provide data around the issues that have an impact on the safety of Cumbria's communities. Data cover a range of topics including:

- crime and disorder;
- domestic violence and sexual violence support;
- drug and alcohol misuse;
- fire safety;
- road safety.

Data have been gathered from local, regional and national sources. Analysis has been undertaken to understand which Cumbrian communities have the greatest need for support to stay safe. The document has been written and produced by Cumbria County Council with recorded crime data and public concerns for Cumbria provided by Cumbria Constabulary. Court outcomes data for some crime categories and data relating to fraud, computer misuse and cybercrime have been included for the first time.

The Crime Survey for England and Wales (2021d) show that the COVID-19 pandemic has had a significant impact on crime patterns nationally in the 12 months to March 2021, with the largest decrease in recorded crime occurring during the three-month lockdown period that coincided with the first national lockdown (April to June 2020). Nationally recorded crime decreased by -19% during this period compared with April to June in 2019, with particularly large decreases in theft offences, such as domestic burglary and theft from the person, as more people stayed at home and limited their social contact. However, at the same time some crime categories increased, notably fraud and computer misuse offences as fraudsters took advantage of behavioural changes during the pandemic, such as increased online shopping. The survey estimates that fraud and computer misuse offences increased by +36% in the year ending March 2021 compared to the year ending March 2019 (the latest year for which comparable data are available).

Offences are widely expected to return to pre-pandemic levels as the lessening impact of COVID-19 restrictions continues. However, it may be some time before a full picture is available, as 2021-22 may still be influenced by restrictions in force in the early part of the year.

It should be noted that since April 2018 the way that crimes are recorded by Cumbria Constabulary has changed, and as a result a single crime incident can now result in more than one recorded crime. For example, a single incident involving violence could comprise two notifiable offences against one victim, such as assault and harassment. Prior to April 2018 the harassment would not have been recorded separately. Recorded crime figures continue to be used in this assessment rather than incident data as they paint a picture of the issues facing Cumbria's individuals and communities.

Any ward data reflect boundary changes in place at December 2020.

1.1 Crime and community safety summary

Cumbria is a relatively safe place in which to live, work and visit. In many areas of the county, levels of crime and community safety are better than those experienced nationally and / or regionally. However, evidence suggests that there are some areas of concern regarding crime and community safety.

Links between crime and deprivation are well documented and have long been understood. Within Cumbria there are 56 communities (Lower Super Output Areas (LSOAs)) that rank within the 20% most deprived within England according to the Indices of Multiple Deprivation (IMD) 2019, with the most deprived community in the county located within Central Ward in Barrow-in-Furness. In total, almost two thirds of Cumbria's 56 most deprived communities (62.5%; 35) are located within the 20 wards identified as being least safe.

The wards which data suggest are least safe are show below, by district. The number in brackets after the ward name shows the number of communities (LSOAs) within the ward that rank within the 20% most deprived in England.

1.2 Crime and community safety: who is at risk?

- The group most likely to become victims of all crime are females, aged 31-60 years.
- The group most likely to be offenders (all crime) are males, aged 31-60 years.
- Violence against the person offenders are most likely to be male, aged 31-60 years.
- Victims of violence against the person offences are most likely to be female, aged 31-60 years.
- Victims of alcohol-related violence against the person offences are most likely to be female, aged 31-60 years.
- The group most likely to be offenders in alcohol-related violence against the person offences are males, aged 31-60 years.
- Victims of sexual violence are most likely to be female, aged 11-17 years (the majority of this offending is to cause or incite a child to watch or engage in sexual activity, or sexual communication with a child which is often committed over the internet).
- Sexual violence offenders are most likely to be male, aged 31-60 years.
- Victims of domestic abuse and domestic abuse with sexual violence are most likely to be female, aged 25-34 years.
- People aged 20-39 and 50-69 are most likely to become victims of fraud.
- People aged 20-39 years old are more likely to become a victim of cybercrime.
- Cybercrime victims are more likely to be female.
- Shoplifting offences are more likely to be committed by males, aged 31-60 years.
- Cumbrian offenders managed by the National Probation Service and the Cumbria and Lancashire Community Rehabilitation Company are more likely to be male.
- The group most likely to be offenders of drug trafficking are males, aged 18-60 years.
- Males are more likely than females to be referred to Unity for drug and alcohol misuse support.
- Those aged 35-49 years are more likely to be referred to Unity for drug and alcohol misuse support.
- Under 18s with drug and alcohol misuse problems are more likely to be males; the majority of referrals are aged 15-17 years.
- Males are more than twice as likely as females to die from alcohol-specific causes.
- The main public concerns across Cumbria in 2020 (people who said this is one of their top three concerns) are: people not following Coronavirus rules and guidance; antisocial driving behaviour; antisocial behaviour; drug dealing / drug taking; criminal damage / vandalism.

1.3 Crime and community safety trends

Patterns of crime have been significantly affected by the COVID-19 pandemic in 2020-21, and there have been decreases across many crime categories. However, these cannot be regarded as “improvements” but are a direct result of COVID-19 restrictions providing lack of opportunity, for example in domestic burglaries and alcohol-related crime. Offences are widely expected to return to pre-pandemic levels with the continued lessening of COVID-19 restrictions, although online fraud and cybercrime may be an exception to this.

2.2 Allerdale district

All crime

- Allerdale has two wards within the top 10 highest ward rates for all crime in 2020-21 (St Michael's, 184.4 per 1,000; Moorclose & Moss Bay, 111.8 per 1,000), both significantly higher than the England & Wales rate (77.2 per 1,000).
- Two wards in Allerdale are within the top 10 highest ward rates for alcohol-related crime in 2020-21 (St Michael's, 28.7 per 1,000; St John's, 17.1 per 1,000).

Acquisitive crime

- Highest rate for theft of a motor vehicle offences in 2020-21 of all Cumbria's districts (0.6 per 1,000 population).
- Five wards within the top 10 highest ward rates for theft of a motor vehicle offences in 2020-21 (Crummock & Derwent Valley, 1.6 per 1,000 population; Harrington & Salterbeck, 1.5 per 1,000; Moorclose & Moss Bay, 1.4 per 1,000; Stainburn & Clifton, 1.3 per 1,000; Flimby, 1.2 per 1,000).
- Three wards within the top 10 highest ward rates for theft from vehicle offences in 2020-21 (St Michael's, 2.2 per 1,000 population; Maryport North and Crummock & Derwent Valley (both 1.6 per 1,000)).
- Allerdale has two wards within the top 10 highest ward rates for burglary (residential) offences in 2020-21 (St Michael's, 5.3 per 1,000 population; Moorclose & Moss Bay, 3.6 per 1,000).
- Highest rate along with Eden for burglary (business and community) offences in 2020-21 (1.2 per 1,000 population).
- Three wards within the top 10 highest ward rates for burglary (business and community) offences in 2020-21 (Crummock & Derwent Valley, 5.4 per 1,000 population; St Michael's, 3.0 per 1,000; Seaton & Northside, 2.4 per 1,000).

Violent crime

- Two wards within the top 10 highest ward rates for violence against the person offences in 2020-21 (St Michael's, 66.3 per 1,000; Moorclose & Moss Bay, 53.7 per 1,000).
- Two wards within the top 10 highest ward rates for alcohol-related violence against the person offences in 2020-21 (St Michael's, 15.5 per 1,000 population; St John's, 11.9 per 1,000).
- St Michael's ward is within the top 10 highest ward rates for sexual offences in 2020-21 (5.0 per 1,000).
- St Michael's ward is within the top 10 highest ward rates for alcohol-related sexual offences in 2020-21 (1.4 per 1,000); this is 4.2 times higher than the Cumbria rate (0.3 per 1,000).
- Rate for domestic violence safeguarding records in 2020-21 (15.4 per 1,000) is similar to the county average (15.3 per 1,000).
- St Michael's ward is within the top 10 highest ward rates for controlling and coercive behaviour offences in 2020-21 (1.9 per 1,000); this is almost three times higher than the Cumbria rate (0.7 per 1,000).
- Two wards within the top 10 highest ward rates for stalking and harassment offences in 2020-21 (Moorclose & Moss Bay, 19.5 per 1,000; St Michael's, 17.7 per 1,000).
- Second largest proportional increase in cruelty to children and young people in 2020-21 (+54.5%; +18 incidents).

Missing persons

- Allerdale has the largest decrease in the proportion of missing persons (individuals under 18 years) in 2020-21 (-49.7%; -84 individuals).

Other crime

- Allerdale has two wards within the top 10 highest ward rates for criminal damage (including arson) offences in 2020-21 (St Michael's, 20.2 per 1,000 population; Moorclose & Moss Bay, 17.5 per 1,000).
- Two wards within the top 10 highest ward rates for arson offences in 2020-21 (Maryport South, 1.2 per 1,000 population; Boltons, 1.0 per 1,000).
- St Michael's ward is within the top 10 highest ward rates for hate crime in 2020-21 (3.6 per 1,000); this is 2.6 times the Cumbria rate (1.4 per 1,000).
- Racially motivated hate crimes make up the largest proportion of hate crime offences in Allerdale in 2020-21 (58.5%; 62 offences).

Antisocial behaviour and reoffending

- Two wards within the top 10 highest ward rates for antisocial behaviour incidents in 2020-21 (Crummock & Derwent Valley, 70.0 per 1,000 population; St Michael's, 54.2 per 1,000).
- St Michael's ward is within the top 10 highest ward rates for youth antisocial behaviour incidents in 2020-21 (11.3 per 1,000); this is 3.3 times higher than the Cumbria rate (3.4 per 1,000).
- Allerdale has the highest number of reoffences per reoffender (all ages) in the 12 months to September 2019 (4.2 reoffences per reoffender).

Drug and alcohol misuse

- Unity Workington has the second largest proportion of new referrals and existing clients seeking support from Unity Drug and Alcohol Services in 2020-21 with opiates as the main reason (66.7%).
- Allerdale has the second highest rate for drug offences (trafficking and possession) in 2020-21 (2.8 per 1,000 population).
- Three wards within the top 10 highest ward rates for drug possession offences in 2020-21 (St Michael's, 13.8 per 1,000 population; St John's, 5.1 per 1,000; Broughton St Bridgets, 4.4 per 1,000).
- The rate in St Michael's ward for drug possession offences in 2020-21 (13.8 per 1,000), is the highest of all Cumbria's wards, and 7.1 times higher than the overall Cumbria rate (1.9 per 1,000).
- St John's ward is within the top 10 highest ward rates for drug trafficking offences in 2020-21 (0.9 per 1,000).
- The rate for deaths related to drug poisoning (12.4 age standardised mortality rate per 100,000 population) is 1.6 times higher in 2018-20 in Allerdale than in England (7.6).
- The rate for deaths related to drug misuse (8.8 age standardised mortality rate per 100,000) is 1.8 times higher in 2018-20 in Allerdale than in England (5.0).

Fire safety

- Highest rate for all fires in 2020-21 of all Cumbria's districts (3.5 per 1,000 population).
- Allerdale has four wards within the top 10 highest ward rates for all fires in 2020-21 (Crummock & Derwent Valley, 8.1 per 1,000 population; Moorclose & Moss Bay, 8.0 per 1,000; Seaton & Northside, 7.6 per 1,000; Flimby, 7.1 per 1,000).
- The rate for deliberate fires (1.5 per 1,000 population) is 1.4 times higher in 2020-21 in Allerdale than the Cumbria average (1.1 per 1,000).
- Four of Allerdale's wards are within the top 10 highest ward rates for deliberate fires in 2020-21 (Moorclose & Moss Bay, 5.8 per 1,000; Seaton & Northside, 4.7 per 1,000; Flimby, 4.1 per 1,000; St Michael's, 3.0 per 1,000).

Road safety

- The rate for those Killed and Seriously Injured (KSI) (0.6 per 1,000 population) is 1.5 times higher in 2020 in Allerdale than in England & Wales (0.4 per 1,000).
- The rate for child KSIs (0.3 per 1,000 population aged 0-15 years) is 2.1 times higher in 2020 in Allerdale than in England and Wales (0.1 per 1,000 population aged 0-15 years).

Local concerns

- Allerdale residents' top three concerns in 2020 are: antisocial behaviour, people not following coronavirus rules and guidance, antisocial driving behaviour.

2.3 Barrow-in-Furness district

All crime

- The rate for all crime in 2020-21 in Barrow-in-Furness (80.4 per 1,000 population) is higher than the national (England & Wales) rate (77.2 per 1000).
- Three wards within the top 10 highest ward rates for all crime in 2020-21 (Hindpool, 242.4 per 1,000 population; Barrow Island, 174.1 per 1,000; Central, 149.9 per 1,000).
- Hindpool ward has the highest rate for all crime of all Cumbria's wards in 2020-21 (242.4 per 1,000), 3.1 times higher than the national (England & Wales) rate of 77.2 per 1,000 population.
- Highest rate for all alcohol-related crime in 2020-21 of all Cumbria's districts (11.0 per 1,000 population).
- Three wards in Barrow-in-Furness are within the top 10 highest ward rates for alcohol-related crime in 2020-21 (Barrow Island, 41.0 per 1,000 population; Hindpool, 38.3 per 1,000; Central, 22.1 per 1,000). Barrow Island has the highest rate of all Cumbria's wards.

Acquisitive crime

- Barrow-in-Furness has the lowest rate for theft from vehicle offences in 2020-21 of all Cumbria's districts (0.4 per 1,000 population).
- The district has three wards within the top 10 highest ward rates for burglary (residential) offences in 2020-21 (Barrow Island, 9.0 per 1,000 population; Central, 6.1 per 1,000; Hindpool, 4.4 per 1,000).
- Hindpool ward is within the top 10 highest ward rates for burglary (business and community) offences in 2020-21 (4.4 per 1,000).

Violent crime

- Highest rate for violence against the person offences in 2020-21 of all Cumbria's districts (38.4 per 1,000 population).

- Eden has six wards within the top 10 highest ward rates for theft from a vehicle offences in 2020-21 (Brough, 3.7 per 1,000 population; Appleby (Appleby) 3.5 per 1,000; Penrith West, 3.5 per 1,000; Greystoke, 2.3 per 1,000; Long Marton, 1.7 per 1,000; Appleby (Bongate), 1.5 per 1,000).

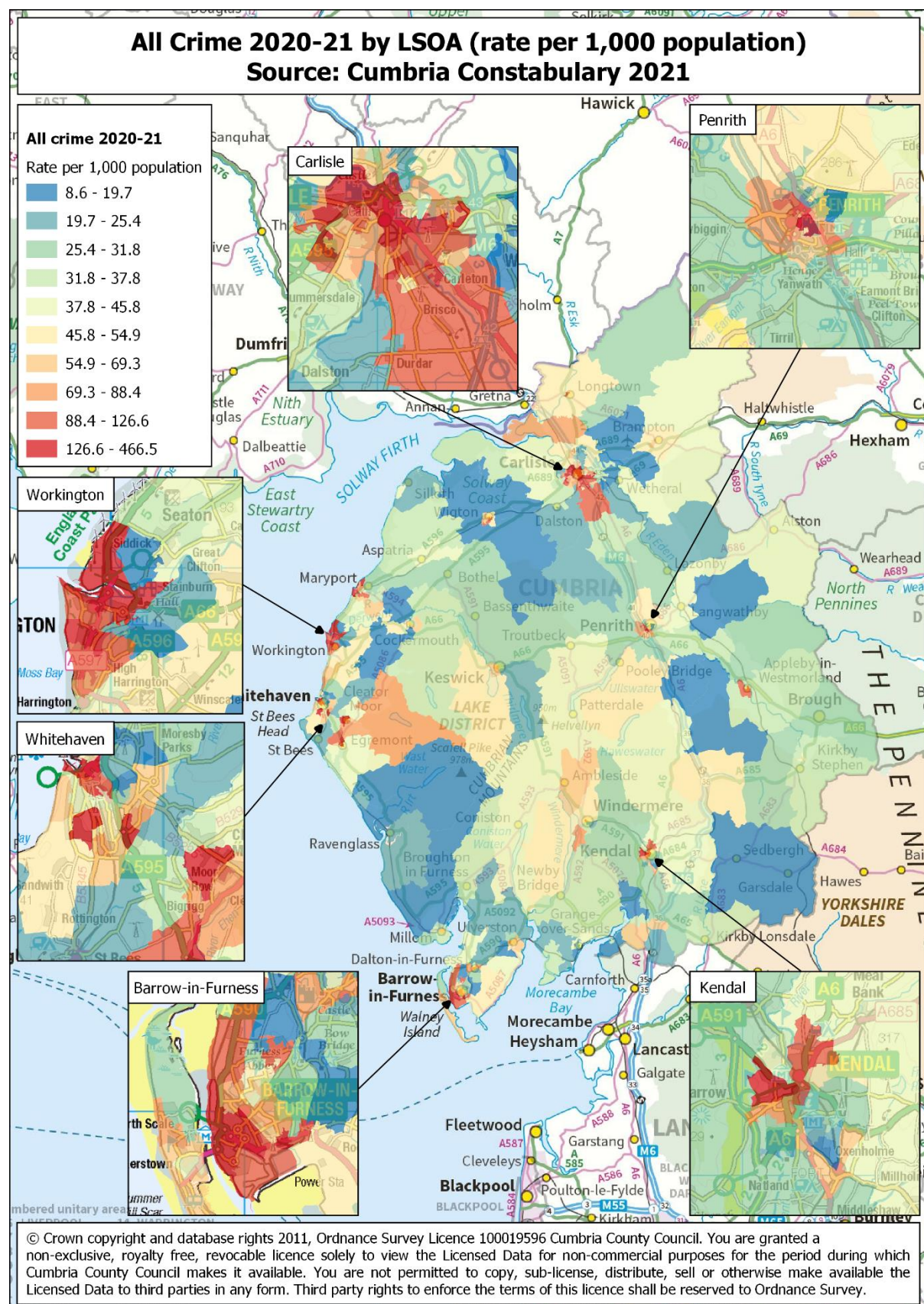

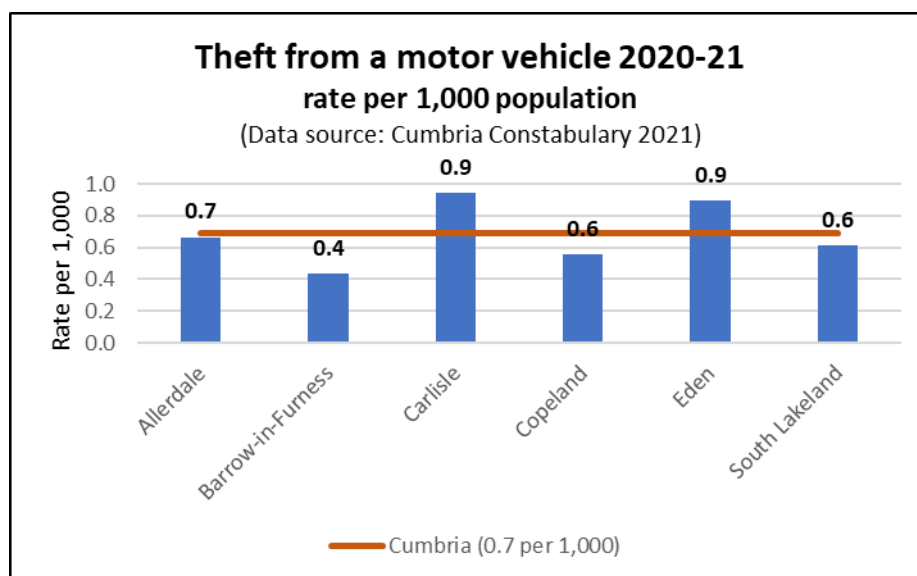
3.3 Rates and trends: Map - all recorded crime rates by LSOA

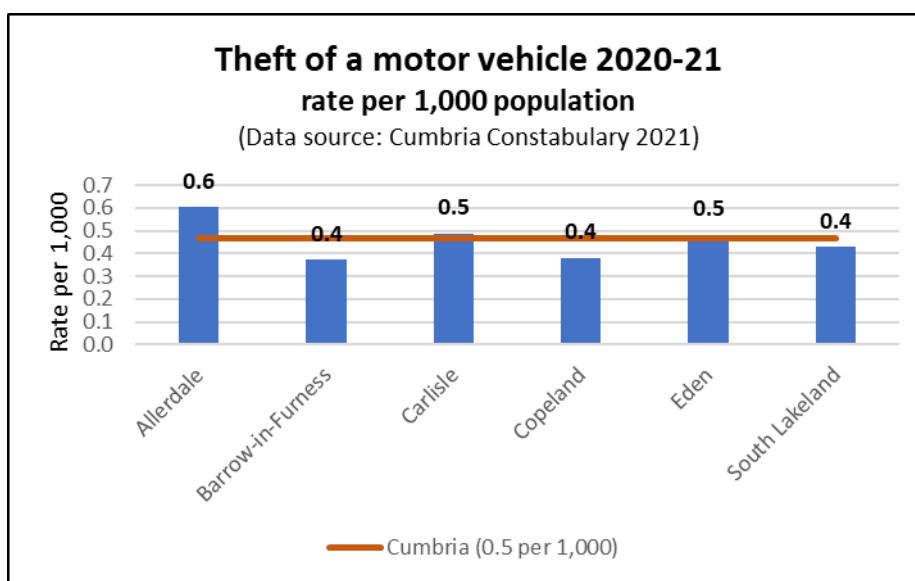

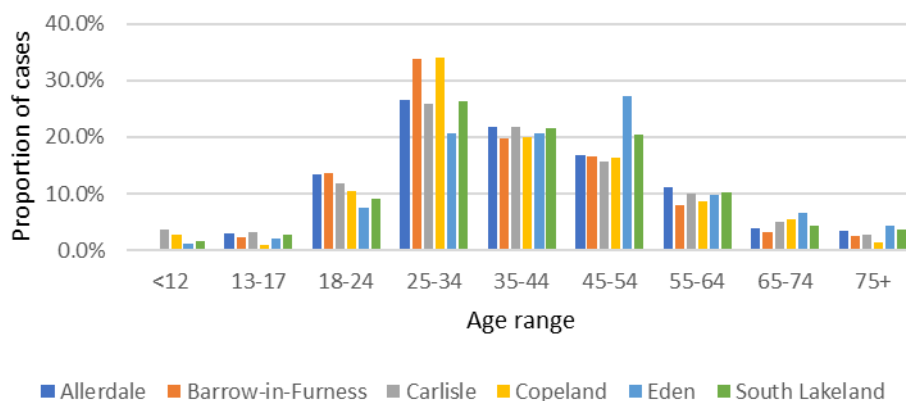

Victim Support, supported cases by age range and district

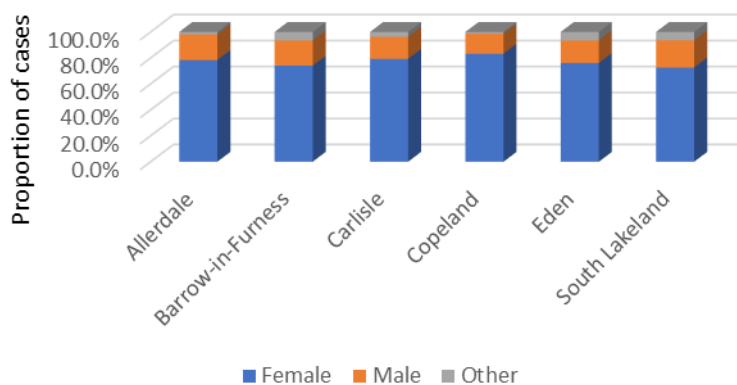

Victim Support, supported cases by gender

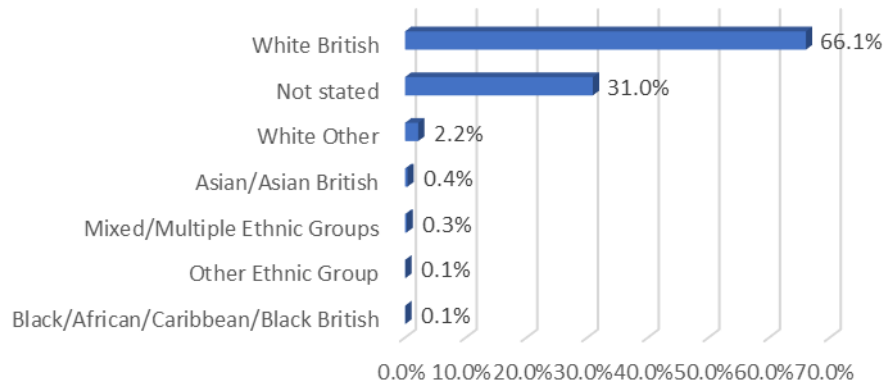

Victim Support, supported cases by ethnicity

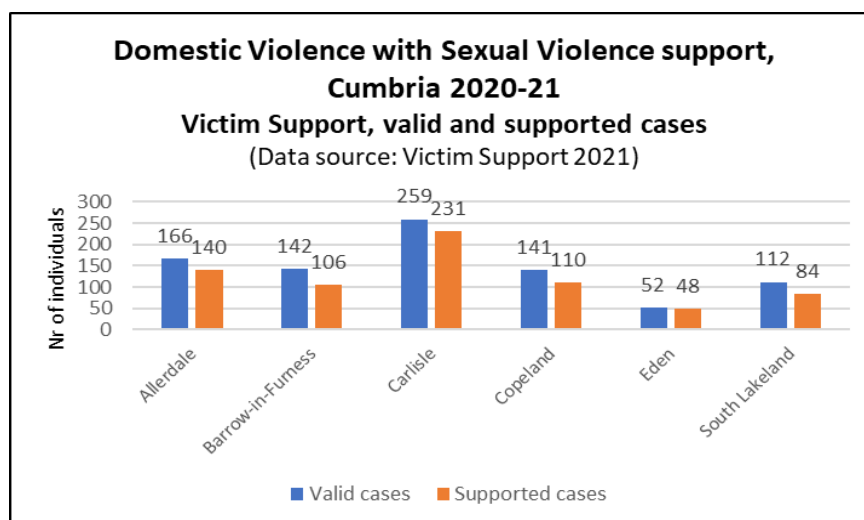

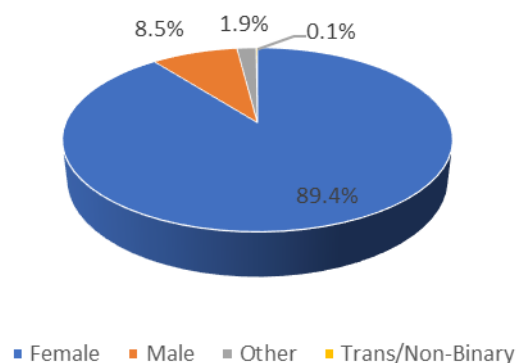
Domestic Violence with Sexual Violence support, Cumbria 2020-21

Victim Support, supported cases by age (Data source: Victim Support)



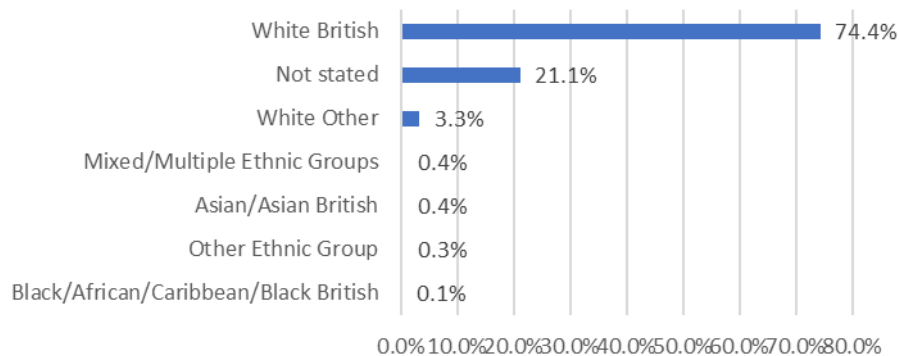
Domestic Violence with Sexual Violence support, Cumbria 2020-21

Safety Net outcome summary – children and young people





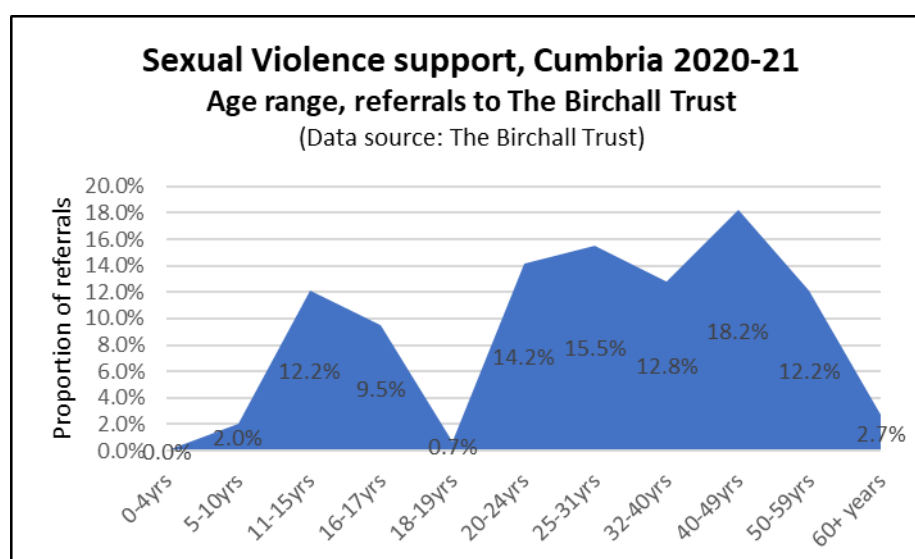

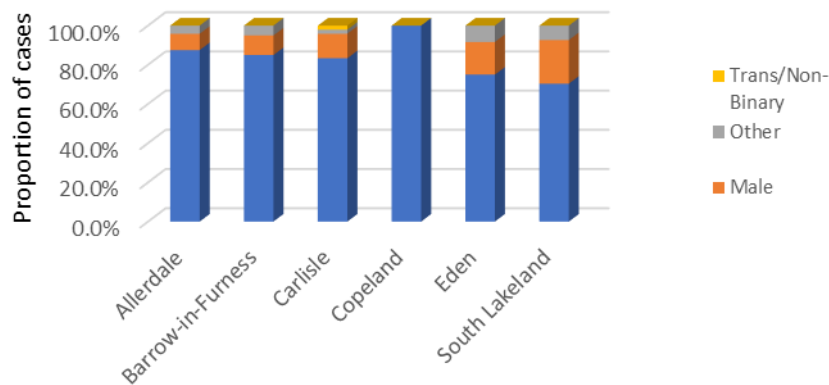

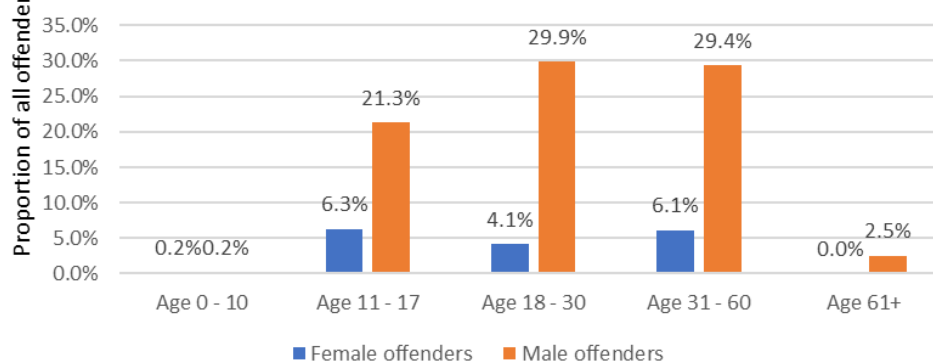

proportion of offenders by age and gender

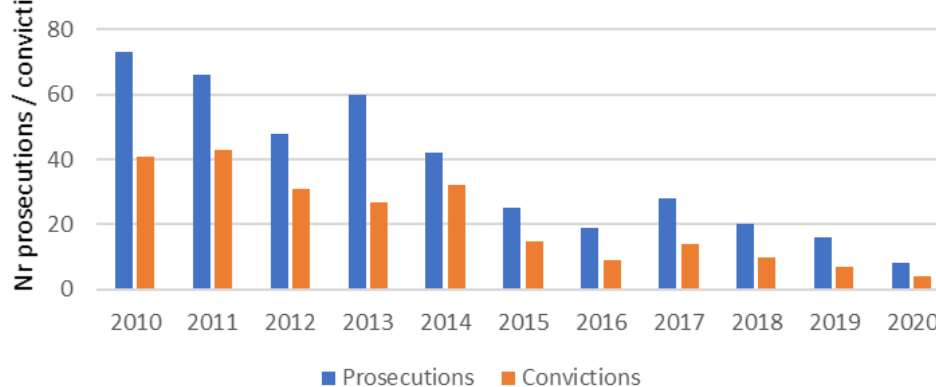

Antisocial behaviour incidents (all) increased across all Cumbria's districts in 2020-21. It is important to note that these incidents include reports of people breaching COVID-19 regulations and government guidelines. At the end of March 2021, over two fifths (43.1%) of antisocial behaviour incidents were tagged as COVID-19 related. Tourist hotspots in particular saw a larger volume of reports, and this is reflected in high rates for antisocial behaviour in some wards within Cumbria's tourist areas. However, at the same time, reductions were seen in youth antisocial behaviour incidents. This may reflect the impact of periods of lockdown and school closures, although the reason is not fully understood.

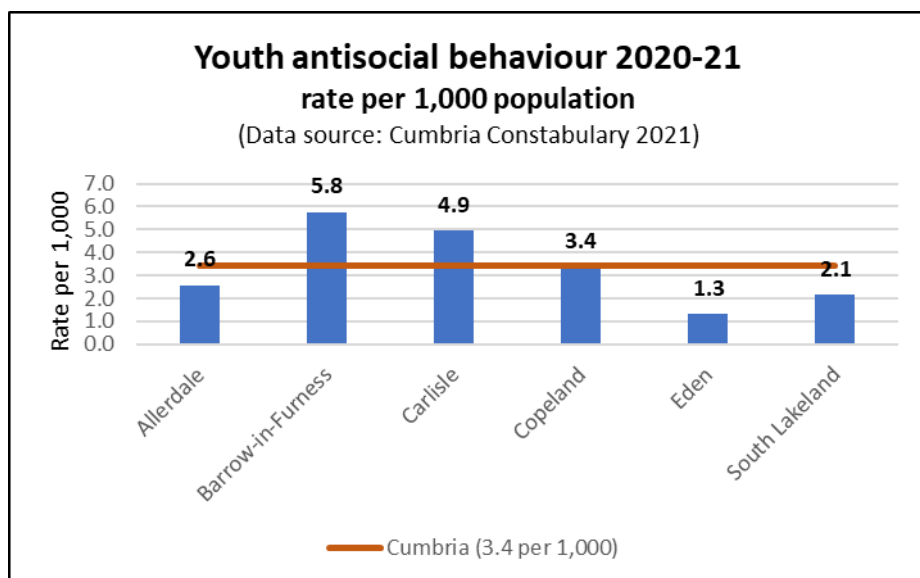

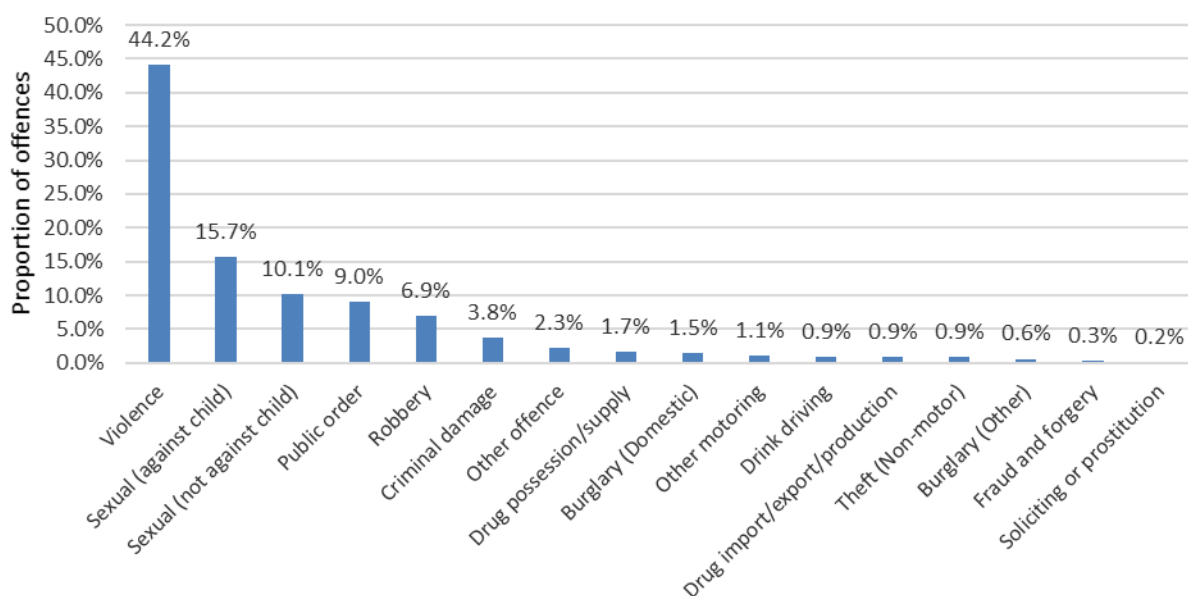

Caseload by offence type at 31 March 2021

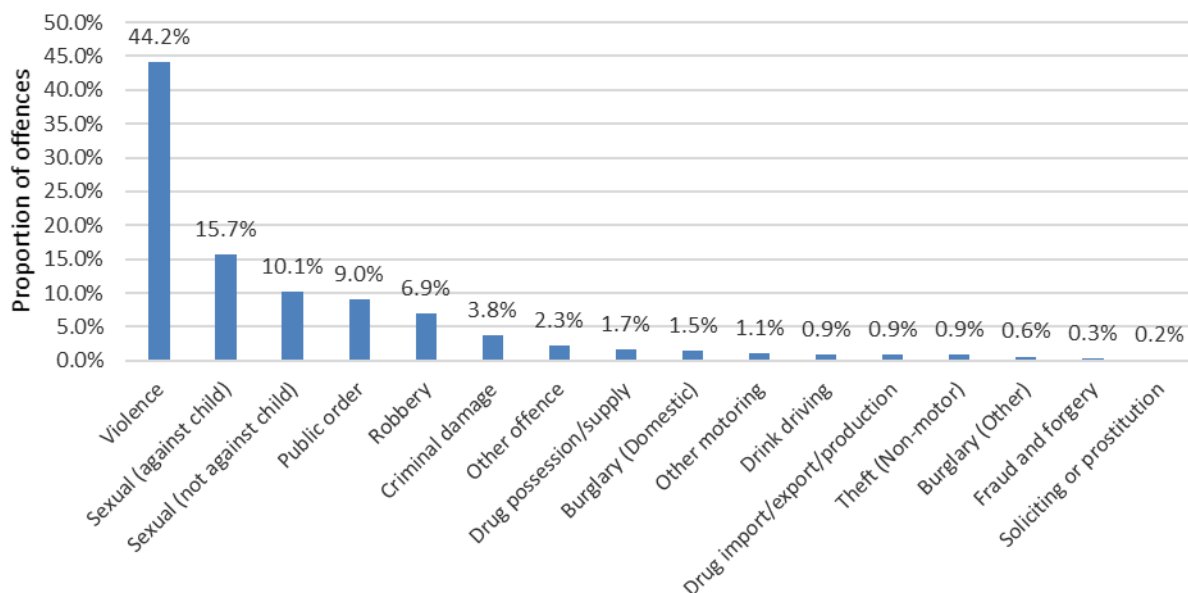

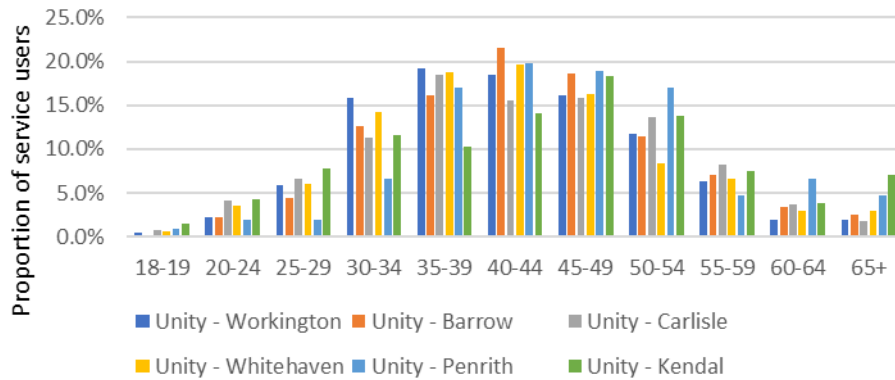

(new and existing service users)

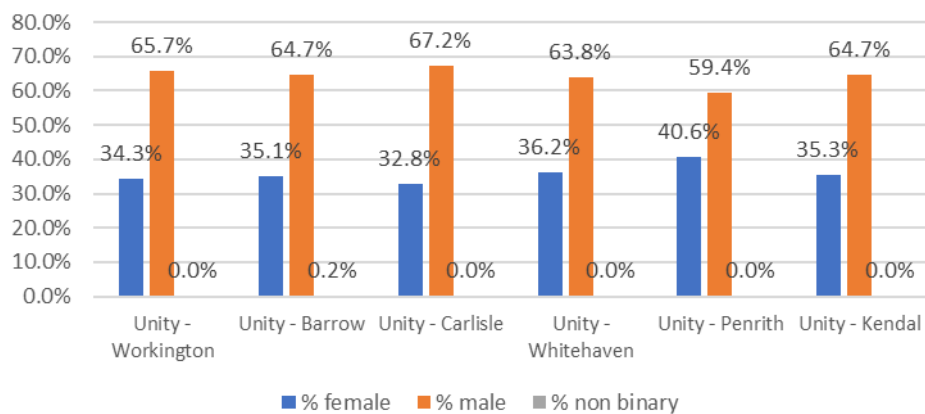

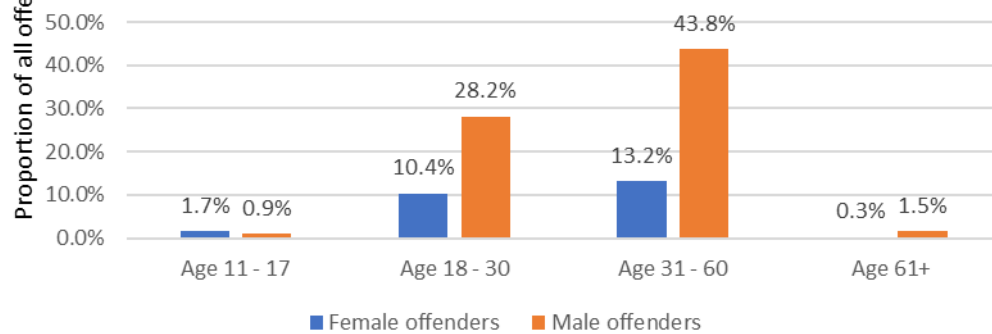
Cumbria, alcohol-related violence against the person 2020-21 proportion of victims by age and gender

Cumbria, alcohol-related violence against the person 2020-21 proportion of offenders by age and gender

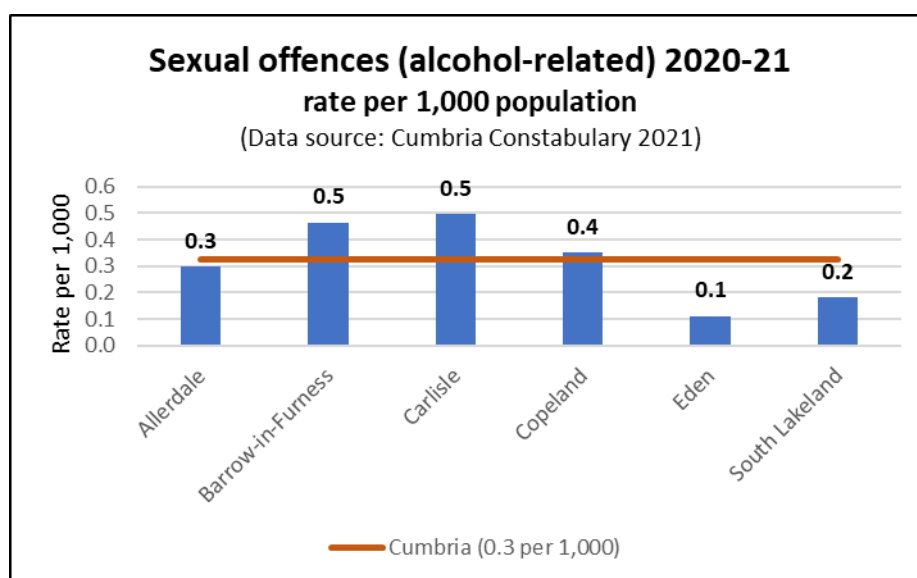
