Commons Act 2006 - Section 19 2(a) Notice of application to correct the register

Notice is hereby given that an application has been made by **David Jackson & Angela Mary Jackson** ("the Applicants") to Cumbria County Council as Commons Registration Authority, under Section 19 paragraph 2(a) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to register unit CL39 Ravenstonedale Common.

A summary of the effect of the application is as follows: Application number 153 made on the 15th March 1968 resulted in the right to graze 460 sheep with their lambs, or cattle and sheep together on the basis of 1 beast equivalent to 10 sheep, over the whole of the land comprised in this register unit, being recorded at entry 36 as attached to O.S. plots numbered 55, 160, 161, 164, 164a, 166, 167, 175, 176, 178, 179, 191, 192, 193, 194, 195, 195a, 196, 197, 199, 273, 275, 276, 276a, 277, 280, 281, 282, 283, 284, 285, 522, 525, 526, 527, 528 and 529 on the O.S. map (Edition of 1915) of the parish of Ravenstonedale, Westmorland together with part O.S. plot 246 ("the Right").

As a result of three applications made in 1996 ("the 1996 Applications") the Right was split resulting in 155 sheep, 155 sheep and 150 sheep now being recorded as attached to land at entries 94, 95 and 96 respectively. Twelve of the O.S. fields listed at the original entry are no longer listed, whilst O.S. field numbers 279, pt278 and 246 (in its entirety) are now shown as having part of the Right attached. The Applicants claim that as there is a clear disconnect between the percentage areas of land and the percentages of rights transferred in each of the conveyances leading to the 1996 Applications, the effect of the conveyances was to sever the rights from the land. The Applicants therefore claim that the Commons Registration Authority should have treated the rights as severed and shown them as being held in gross as a result of the 1996 Applications.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by deleting the current entries 94, 95 and 96 and creating new entries showing each part of the Right as being held in gross. The names of the applicants listed at entries 94, 95 and 96 as the owners of each part of the Right will remain unchanged on the newly created entries as a result of this application.
