The Commons Act 2006 - Schedule 3 para 2(b) Application to amend the register to record an historic event

Notice is hereby given that an application has been made by **Richard Hodgson Wills** ("the Applicant") to Cumbria County Council as Commons Registration Authority under Schedule 3 paragraph 2(b) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit CL70 Burgh Marsh.

A summary of the effect of the application is as follows: The right to graze 3 stints (one stint equalling one beast or 2½ sheep between 1st May and 28th October: sheep only to be grazed between 8th November and 28th March) and the right in the soil to cut turf and such rights of piscary as may be appurtenant thereto and the right of fishing in the river Eden, on Burgh Marsh comprising the whole of the land in this register unit ("the Right") is currently registered as held in gross at entry 312 of register unit CL70 in the name of the Personal Representatives of John Wills deceased. The Applicant claims that in April 1995 part of the Right (2 stints) was transferred to him from Lilian Inns-Smith. The Applicant seeks by this application to register that part of the Right in his own name.

If the application is granted, the registration authority will give effect to the determination by deleting the current entry (making reference to the new corresponding entries) and making two new entries in the register to show the Applicant as the owner of part of the Right (2 stints) with the remainder of the Right (1 stint) remaining registered in the name of the Personal Representatives of John Wills deceased.

- must state the grounds on which they are made; and

Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on 1st August 2018.
