NOTICE OF DETERMINATION

Application Number: CA3/41

Notice is hereby given that Cumbria County Council, as the Commons Registration Authority ("the CRA"), has considered an application submitted by **Ian Roger Cooper and Hannah Lorrae Ridgeway** ("the Applicants") seeking to apportion the right of common attaching to O.S. field numbers 851, 852, 854, 855, 856, 858, 859, 860, 865, 866, 867, 868, 870, 1006, 1007, 1008, 1009, 1011, 1192, 1193, 1194, 1195, 1196, 1197, 1197a 1198, 1199, 1525, 1557, 1560, 1561, 1562, 1562a, 1563, 1564, 1565, 1566 and 1570 on the O.S. Map (Edition of 1915) of the Parish of Crosby Ravensworth, Westmorland of CL7 Bank Moor adjoining the north east corner of Crosby Ravensworth Fell ("the Right") and to register the apportionment in the register of common land.

Decision

The CRA resolved to accept the application to amend the registers by registering the apportionment of the Right.


Reasons

NOTICE OF APPLICATION FOR APPORTIONMENT OF RIGHTS OF COMMON

Notice is hereby given that an application has been made by **Ian Roger Cooper and Hannah Lorrae Ridgeway** ("The Applicants") to Cumbria County Council as Commons Registration Authority, under Section 8 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014. The application relates to entry number 7 of the common land register unit CL7 Bank Moor adjoining the north east corner of Crosby Ravensworth Fell.

A summary of the effect of the application is as follows: The following right is attached to O.S. field numbers 851, 852, 854, 855, 856, 858, 859, 860, 865, 866, 867, 868, 870, 1006, 1007, 1008, 1009, 1011, 1192, 1193, 1194, 1195, 1196, 1197, 1197a, 1198, 1199, 1525, 1557, 1560, 1561, 1562, 1562a, 1563, 1564, 1565, 1566 and 1570 on the O.S. Map (Editon of 1915) of the Parish of Crosby Ravensworth, Westmorland, and is exercisable over the whole of the land in register unit CL7 Bank Moor adjoining the north east corner of Crosby Ravensworth Fell.

"The right to graze 100 sheep with their followers together with the rights of turbary and to take stone over the whole of the land comprised in this register unit" ("The Right").

Pursuant to the division of the land to which the Right is attached, the Applicants seek by their application to register apportionment of the Right appropriate to the parts of land transferred and now in their ownership.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by making the following amendment to the commons register:

1. Entry number 7 will be deleted and reference made to the new corresponding entries.
2. Addition of supplemental maps.
3. The following entries will be made to the rights section of the commons register to show the proportionate apportionment of the Right to the applicants (a) Ian Roger Cooper and Hannah Lorrae Ridgeway, and (b) John Brian Bowness.
 - a. The right to graze 93.42 sheep with followers together with the rights of turbary and to take stone over the whole of the land comprised in this register unit. The right is attached to O.S. field numbers 851, 852, 854, 855, 856, 858, 859, pt. 860, pt. 867, 868, 1006, 1011, 1192, 1193, 1194, 1195, 1196, 1197, 1197(a), 1198, 1199, 1525, 1557, 1560, 1561, 1562, 1562(a), 1563, 1564, 1565 and 1566 as shown coloured blue on the proposed supplemental map.
 - b. The right to graze 6.58 sheep with followers together with the rights of turbary and to take stone over the whole of the land comprised in this register unit. The right is attached to O.S. field numbers pt. 860, 865, 866, pt. 867, 870, 1007, 1008, 1009 and 1570 as shown coloured red on the proposed supplemental map.


Any person wishing to make representations:

- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must state the grounds on which they are made and must be signed by the person making them;

Any representations made will not be treated as confidential, to determine the application it will be necessary for the authority to disclose information received from you to others, which will include the Applicants and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on **17 January 2022**.
