NOTICE OF APPLICATION TO TRANSFER A RIGHT OF COMMON IN GROSS

Notice is hereby given that an application has been made by **Barbara Fell and Caroline Anne Knowles** ("the Applicants") to Cumberland Council as Commons Registration Authority, under Section 12 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit CL112 Black Combe and White Combe.

A summary of the effect of the application is as follows:

The right to graze 200 adult sheep with their lambs, (rate of exchange 2 geese equal 1 sheep, 10 sheep equal 1 cow, 2 cows equal 1 horse) the right to take bracken for bedding and the right to take peat and stone for use on the holding on Black Combe and White Combe comprising the whole of the land in this register unit ("the Right") is currently registered as held in gross (not attached to land) at entry 18 of register unit CL112 in the name of Dixon Robinson.

The Applicants claim that the Right was transferred to Andrew Fell by way of a Deed dated 2nd November 2023. The transfer does not operate at law until registered by the Commons Registration Authority in the register. The Applicants seek by this application to complete the transfer of ownership and register the Right in Mr Fell's name.

If the application is granted, in whole or in part, the Commons Registration Authority will give effect to the determination by making a new entry in the register showing Andrew Fell as the owner of the Right.

Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of Information Act 2000.

The period for making representations expires at 5pm on 22nd December 2023.
