

## Commons Act 2006 - Section 19(2)(d) NOTICE OF APPLICATION TO CORRECT THE REGISTER

Notice is hereby given that an application has been made by **Carole Cockburn ("the Applicant")** to Cumbria County Council as Commons Registration Authority, under Section 19(2)(d) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to register unit CL4 Crosby Garrett Regulated Common.

A summary of the effect of the application is as follows: The right to graze (a) 160 sheep or (b) such commonable animals equivalent to 160 stints together with the right of turbary and the right to take stone over the whole of the land comprised in this register unit is registered as held in gross (unattached) at entry number 69 in the name of Carole Cockburn of South House, Soulby, Kirkby Stephen, Cumbria, CA17 4PJ. The Applicant's address changed to New Hall, Soulby, Kirkby Stephen, Cumbria, CA17 4PH and this application seeks to record the new address in the Register.

If the application is granted, the registration authority will give effect to the determination by amending the Register to show the Applicant's new address in columns 3 and 5.

Any person wishing to make representations:

- must quote the Application No. CA10/60
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations made will not be treated as confidential. To determine the application, it will be necessary for the Commons Registration Authority to disclose information received to others, which will include the applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The date on which the period for making representations expires is **10<sup>th</sup> May 2023**.
