NOTICE OF APPLICATION TO CORRECT THE REGISTER

Notice is hereby given that an application has been made by Anne Fisher and David Frank Wearing ("the Applicants") to Cumbria County Council as commons registration authority, under Section 19(2)(b) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register units CL206 Ease Meadow and CL207 Intack.

A summary of the effect of the application is as follows:

The rights at entry 2 of CL206 and entry 2 of CL207 were registered pursuant to application number 1312 dated 2 January 1970 made by Ralph Wearing. The application being undisputed became final on 31 July 1970. Both rights are attached to Far Houses Farm, Grizebeck, Kirkby in Furness, comprised of O.S. fields numbers 619, 318, 297, 298, 295, 292, 293, 294, 299, 271, 275, 300, 302, 304, 303, 305, 306, 319, and 291 on the O.S. map (edition of 1913) of the parish of Kirkby Ireleth.

The Applicants claim that O.S. field number 619 cannot be located on the O.S. map (edition of 1913) of the parish of Kirkby Ireleth and that it was included in the particulars of the land to which the rights are attached by mistake made by Mr Wearing. The Applicant requests that this mistake is corrected and O.S. field number 619 is removed from column 5 of both entries.

If the application is granted, the registration authority will give effect to determination by deleting entry 2 in CL206 and entry 2 in CL207 and replace them with a new entry in each register unit showing the rights as attached only to O.S. fields numbers 318, 297, 298, 295, 292, 293, 294, 299, 271, 275, 300, 302, 304, 303, 305, 306, 319, and 291 on the O.S. map (edition of 1913) of the parish of Kirkby Ireleth.

Any person wishing to make representations:

- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
