NOTICE OF APPLICATION TO CORRECT THE REGISTER

Notice is hereby given that an application has been made by **Graham Joseph Park and Cherith Lavinia Park** ("the Applicants") to Cumberland Council as commons registration authority, under Section 19(2)(a) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit CL105 Longmoor part of which is shown hatched green on the plan accompanying this notice ("the Notice Plan").

A summary of the effect of the application is as follows:

Common land register unit CL105 was provisionally registered as common land on 10 June 1968 pursuant to application number 152 made by Ennerdale & Kinniside Parish Council ("the Original Application"). The registration, being undisputed, became final on 1 October 1970.

The Applicants claim that an error was made by the commons registration authority when creating the current register map. The Applicants claim that the Original Application excluded the land shown outlined red on the Notice Plan ("the Application Land") and that the registration authority made a mistake in including the Application Land within the boundary of CL105. The Applicants seek the removal of the Application Land from the Register of Common Land and Town and Village Greens.

If the application is granted, the registration authority will give effect to determination by deregistering the Application Land, which will entail the addition of a registration amendment entry in register unit CL105 confirming the deregistration of the part, and the amendment or preparation of a fresh edition of the register map showing the Application Land as having been removed from CL105.

Any person wishing to make representations:

- must quote the Application No. CA10/66
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on 26 July 2023.
