NOTICE OF APPLICATION TO TRANSFER A RIGHT OF COMMON IN GROSS

Please note this notice replaces the notice issued on 21st June 2024.

Notice is hereby given that an application has been made Michael James Waning ("the Applicant") to Cumberland Council as Commons Registration Authority, under Section 12 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit CL70 Burgh Marsh.

A summary of the effect of the application is as follows:

The right to graze 15 stints (one stint equalling one beast or 2 ½ sheep, between 1st May and 28th October: Sheep only to be grazed between 8th November and 28th March) and the right in the soil to cut turf and such rights of piscary as may be appurtenant thereto, on Burgh Marsh comprising the whole of the land in this register unit ("the Right") is currently registered as held in gross (not attached to land) at entry 13 of register unit CL70 in the name of Robert Taylor Mattinson.

The Applicant claims that part of the Right equalling 3 stints was transferred to him by way of a Deed dated 5th June 2024. The transfer does not operate at law until registered by the Commons Registration Authority in the register. The Applicant seeks by this application to complete the transfer of ownership and register the said part of the Right in his name.

If the application is granted, in whole or in part, the Commons Registration Authority will give effect to the determination by making a new entry in the register showing the Applicant as the owner of the aforementioned part of the Right.

Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on 14th August 2024.
