In addition, there may be a requirement to carry out grounds' maintenance works within the role. To ensure that all work activities are carried out with focus on performance, safety, and quality. To support Highway Team Leaders in the inspection and repair of the highway network and by responding to service requests.

Be willing to take part in the winter maintenance function or other out of hour's functions.</li> <li>8. Mixing and laying materials such as cement, concrete and bituminous.</li> <li>9. Operate specialist small plant and tools.</li> <li>10. Minor civil works including – patching, kerbing, flagging, block paving, surfacing, drainage, walling etc.</li> <li>11.
