hereby apply for an order under Section 53(2) of the Wildlife and Countryside Act 1981 modifying the Definitive Map and Statement for the area by:-

- a) Adding the Public Bridleway which runs from Point A on the application map (OSGR NY 25198 39066) the junction of the application route and U2129 101, to Point B at Rash Farm (OSGR NY 25253 39303).
- b) Adding the Public Bridleway which runs from Point B on the application map (OSGR NY 25253 39303) to Point C (OSGR NY 24841 39448).
- c) Adding the Public Bridleway which runs from Point C on the application map (OSGR NY 24841 39448) to Point D (OSGR NY 24613 39256) the junction of the application route and C2021 101.
- d) Adding the Public Bridleway which runs from Point D on the application map (OSGR NY 24613 39256) to Point E (OSGR NY 24568 39713) the junction of the application route and C2020 101.
- e) Adding the Public Bridleway which runs from Point E on the application map (OSGR NY 24568 39713) to Point F (OSGR NY 24336 39831) the western end of the application route.

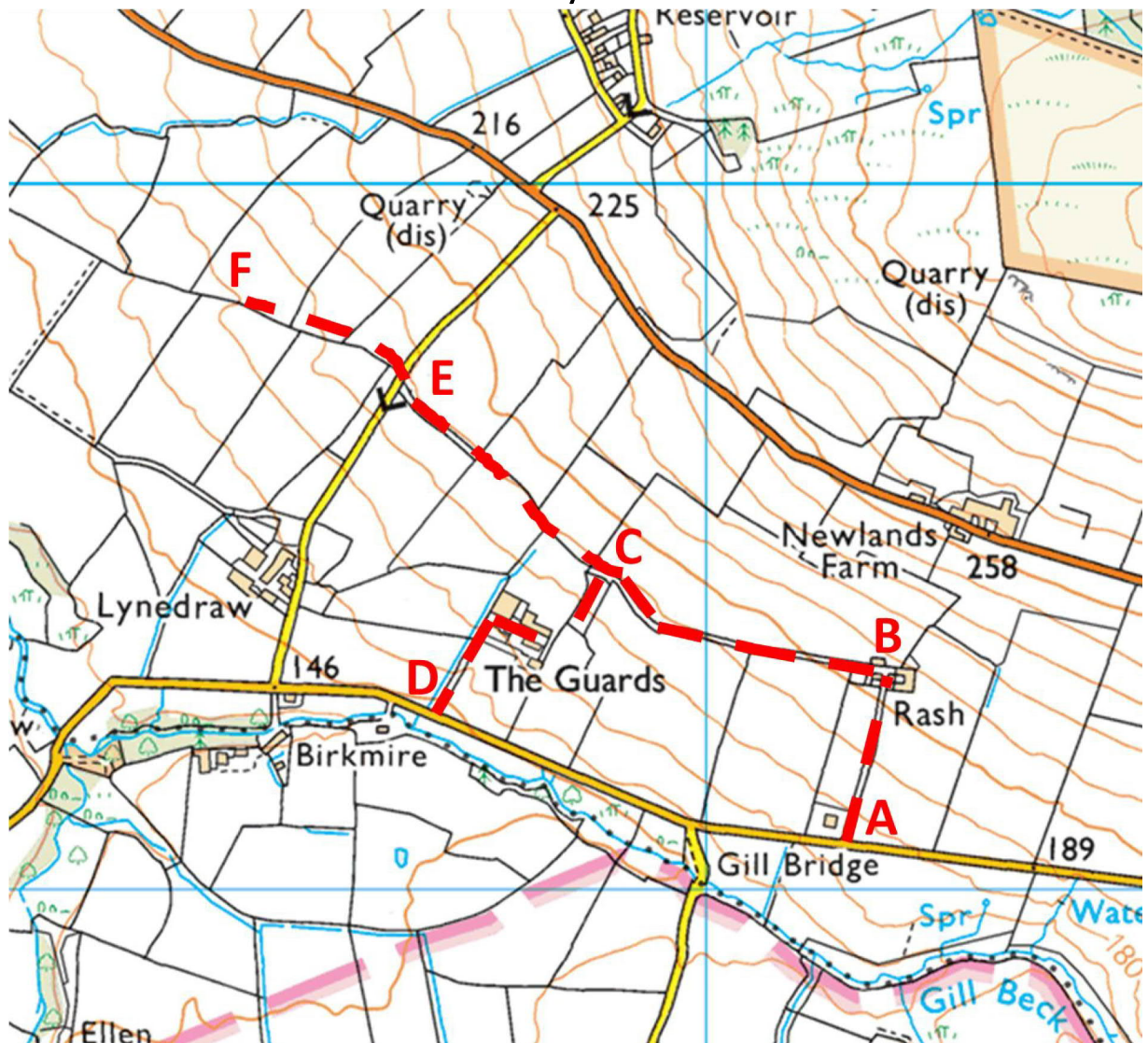
