

- 1. My name is Geoff Brooks. I am acting on behalf of Ramblers¹ the applicant for the order. I am a retired research and development chemist and a long-time member of Ramblers.
- 2. This application is made because, on the cut off day,
 - The effect of s.53(1) and (2) Countryside and Rights of Way Act 2000 on a public path that existed prior to 1949, still exists on the cut-off date, and hasn't been a highway of a different description in between, and is not shown in the definitive map and statement at all is to extinguish all rights on that route. (This applies if the route is determined to be a footpath or bridleway.)
- 3. I believe this application will pass the planned Preliminary Assessment Test required by para 2 Sch 13A Wildlife and Countryside Act 1981 because:
 - a. This application statement includes explanations as to how the evidence applies to the application route, and
 - b. The application contains the following forms of supporting evidence:
 - (1) Maps and other documents which, over a period of time, and taken together, provide evidence of reputation that the order route is part of the public road network.

THE APPLICATION ROUTE

4. The application route runs from Potter Fell Road U5270 at SD 516980 to join the Existing Footpath from East View, numbered 575026 on the Definitive Map for Cumbria, at SD 518989. The application route is not currently shown on the definitive map of rights of way for Cumbria. It is shown on the plan below from point A to point B.
