## CUMBERLAND COUNCIL (FOOTPATH NO 416036 PARISH OF MILLOM WITHOUT) PUBLIC PATH EXTINGUISHMENT AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2024

This Order is made by Cumberland Council ("the authority") under Section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that the footpath described in paragraph 1 below is not needed for public use.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the Authority that the Cumberland Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act namely the extinguishment (as authorised by this Order) of a highway hitherto shown or required to be shown in the map and statement.

#### BY THIS ORDER:

- The public right of way over the land situate at Low Lowscales in the Parish of Millom Without shown by a continuous bold line on the map attached to this Order and described in the Part 1 of the Schedule to this order shall be extinguished after seven days from the date of confirmation of this Order and thereupon the Cumberland Definitive Statement shall be modified as described in Part 2 of the Schedule to this order.
- Despite this Order all statutory undertakers shall continue to have any existing rights of access to and egress from any apparatus, equipment and plant accessible only from the right of way referred to in Part 1 of the Schedule to this Order.
- The Order shall be referred to as the Cumberland Council (Footpath no 416036
  Parish of Millom Without) Public Path Extinguishment and Definitive Map and
  Statement Modification Order 2024.


