CUMBERLAND COUNCIL (FOOTPATH NOS 109397, 109401 AND 109402 CITY OF CARLISLE) PUBLIC PATH STOPPING UP AND DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2024

This Order is made by Cumberland Council ("the authority") under Section 257 of the Town and Country Planning Act 1990 ("the 1990 Act") because it is satisfied that it is necessary to stop up and divert the footpaths to which this order relates in order to enable development to be carried out in accordance with planning permission granted under Part III of the 1990 Act namely: No. ref 19/0905 (appeal reference APP/E0915/W/21/3266806) Residential Development of 80 dwellings at Deer Park, Carlisle.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the Authority that the Cumberland Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act namely the stopping up and diversion (as authorised by this Order) of a highway hitherto shown or required to be shown in the map and statement.

#### BY THIS ORDER:

- 1. The public footpaths over the land situate at Deer Park in the City of Carlisle shown by continuous bold lines on the map attached to this Order and described in Part 1 of the Schedule to this order shall be stopped up as provided below.
- 2. There shall be created to the reasonable satisfaction of the authority alternative highways for use as replacements for the said footpaths as provided in Part 2 of the Schedule and shown by bold broken lines on the map contained in this Order.
- The Cumberland Definitive Statement shall be modified as described in Part 3 of the Schedule to this Order.
- 4. Despite this Order all statutory undertakers shall continue to have any existing rights of access to and egress from any apparatus, equipment and plant accessible only from the rights of way referred to in Part 1 of the Schedule to this Order.
- The Order shall be cited as the Cumberland Council (Footpath Nos 109397, 109401 and 109402 City of Carlisle) Public Path Stopping Up and Diversion and Definitive Map and Statement Modification Order 2024 and shall take effect upon confirmation.


