- 1. For the purposes of this Order the relevant date shall be 1 March 2023.
- 2. The definitive map and statement for the County of Cumbria shall be modified as described in the Schedule and shown on the map attached to the order.
- This Order shall have effect on the date it is confirmed and may be cited as the Cumbria County Council (Parish of Burgh by Sands:District of Carlisle) Definitive Map Modification Order (No 1) 2023.


