

## GOVERNING BODY OF CALDEW SCHOOL

Notice is given in accordance with section 19(3) of the Education and Inspections Act 2006 that the Governing Body of Caldew School intends to make a prescribed alteration to Caldew (Foundation) School (DCSF No 5413), Dalston, Carlisle CA5 7NN from 01 September 2008.

It is proposed that there will be Special Education Needs provision reserved for up to 16 pupils with special education needs (autistic spectrum disorders) at Caldew School from 1 September 2008. The number of pupils to be admitted to the school at age 11 from 1 September 2008 will remain at 174.

No new or additional site will be required if these proposals are implemented.

The Governing Body of Caldew School will be responsible for implementing the proposal.

### **Explanatory Notes**

1. The Governing Body of Caldew School with the support of Cumbria County Council is proposing a prescribed alteration to the school by the provision of strategic facilities for children with special needs. It is intended that the change will be implemented in September 2008.
2. The facility will cater for up to 16 pupils with autistic spectrum disorders (ASD)
3. Subject to the pupils referred to in paragraphs 1 and 2 above who will not necessarily be from the catchment area, it is intended that the school will continue to serve the existing catchment area. Admissions to the school will be in accordance with the Governors' admissions policy which is published each year.
4. The Governors' admissions policy allows a pupil who holds a Statement of Special Educational Needs which names Caldew School to be admitted as the first priority. The current admission authority for the school is the Governing Body of Caldew School. After the prescribed alteration is implemented by the Governing Body of Caldew School this will remain unchanged.
5. Any representations made (and not withdrawn in writing) within the representation period which ends on 19 October 2007 will be considered by Cumbria County Council.
