# Why increase pupil numbers?

- Across Carlisle birth rate has been increasing
- Means increased demand for school places
- Council has legal duty to provide enough places
- Around 15 extra places needed to meet demand in future years
- Would increase capacity to 75 pupils per year group
- Gives overall capacity of 525 pupils (plus nursery) either across both schools or in one all-through primary school.

## Options for expansion (1)

**Basically 2 options:** 

Option1: Keep the two separate schools but expand each of them

Option 2: Amalgamate the two schools to create a new larger all-through primary school



# Options for expansion (2)

- There are two ways to achieve option 2:
  - Close Nursery & Infants School and expand Junior School
  - Close Junior School and expand Nursery & Infants School
- Both technically possible but both achieve the same – new all-through primary school



## Benefits of separate schools

- Retention of two successful schools
- Class organisation and structures maintained
- Personalised and detailed knowledge of the pupils and their families
- Experience of transition which can help to prepare pupils for the move to secondary education at the end of Key Stage 2
- A key stage-specific environment allowing children to thrive
- A curriculum tailored to the needs of the age-range delivered by specialist staff teams
- A nurturing environment for very young children



## **Benefits of amalgamation**

- No need to transfer to a 'new' school at the end of Key Stage 1
- Shared consistent vision and values across the school
- Consistent engagement with parents across the primary phase
- Expertise within whole school can be better targeted across the full age range
- More resources to be spent directly on teaching and learning
- Professional development opportunities for staff within allthrough environment
- In line with the county council's stated policy for all-through primary schools.
