The proposal is to discontinue Fairfield Junior School from 31st August 2013.

Consultation documents were provided to: staff and governors at the school, parents of current pupils at the school via the school; other schools affected by the proposal, elected members of Cumbria County Council in the affected wards and cabinet members, parish councils, Department for Education, Diocese of Lancaster Education Service, Carlisle Diocese, Copeland Borough Council Chief Executive, local libraries, trade unions, other local authority officers and local press.

Objectives

5. The objectives of the proposal.

The objectives of the proposal are the closure of Fairfield Junior School and, via a linked proposal, the extension of the age range at Fairfield Infant School to form an all through primary school for children aged 3-11 years old. The newly-formed Fairfield Primary School will use the existing buildings of Fairfield Infant and Fairfield Junior schools.

Standards and Diversity

6. A statement and supporting evidence indicating how the proposals will impact on the standards, diversity and quality of education in the area.

Fairfield Junior School is currently rated by Ofsted as a 'Good school with many outstanding features'. While Fairfield Infant School is currently rated by Ofsted as 'Outstanding'.

Fairfield Infant and Fairfield Junior Schools share the same site. Currently, there can be no guarantee that a pupil enrolled at Fairfield Infant School will automatically transfer and have a place at Fairfield Junior School. This may go against parents' expectations. The amalgamation of the schools provides parents and children with additional certainty in terms of their primary education. Amalgamation would also provide the following educational benefits;

- Continuity of experience for children, with no need to transfer to a 'new' school at the end of Key Stage 1
- Shared consistent vision and values across the school
- Consistent engagement with parents across the primary phase, with no need to transfer information at the end of a Key Stage
- Expertise within the whole school can be better targeted across the full age range
- Combination of roles and services allowing more resources to be spent directly on teaching and learning
- Professional development opportunities for staff within an all-through environment

The closure of Fairfield Junior School and the change of age range of Fairfield Infant School to form Fairfield Primary School is likely to have a positive impact upon standards and diversity for children in the area.

Need for places

8. A statement and supporting evidence about the need for places in the area including whether there is sufficient capacity to accommodate displaced pupils.

In October 2012 Fairfield Junior School has a total of 225 children on roll and a net capacity of 240. There is an ongoing need for Key Stage 2 places within the town.

The extended Fairfield Infant School (to form Fairfield Primary School) will accommodate 'displaced' pupils; the school will have a net capacity of 420 and a Published Admission Number of 60.

Current School Information

10. Information as to the numbers, age range, sex and special educational needs of pupils (distinguishing between boarding and day pupils) for whom provision is made at the school.

Fairfield Junior School caters for boys and girls aged 7-11 years old. As of October 2012 (School Census), there were 225 pupils on roll. 28 (12.4%) of those pupils were assessed as having special educational needs. The school is not a boarding school.

Displaced Pupils

- 11. Details of the schools or FE colleges which pupils at the school for whom provision is to be discontinued will be offered places, including:
- any interim arrangements;
- b) where the school included provision that is recognised by the LA as

reserved for children with special educational needs, the alternative provision to be made for pupils in the school's reserved provision; and

c) in the case of special schools, alternative provision made by LAs other than the authority which maintains the school.

For 'displaced' pupils from Fairfield Junior School, places will be offered at Fairfield Infant School, Gallowbarrow, Cockermouth, Cumbria. CA13 0DX, where it is proposed that the age range be extended.

- a) It is proposed that Fairfield Junior School closes on 31st August 2013; the pupils will then start in their new school at the beginning of the new academic year in September 2013; no interim arrangements are required in respect of pupil places. There will be an extensive transition programme for pupils transferring that will take place through the 2013 summer term.

- 12. Details of any other measures proposed to be taken to increase the number of school or FE college places available in consequence of the proposed discontinuance.

Proposals to extend the age range and enlarge Fairfield Infant School, to form Fairfield Primary School, will directly and commensurately replace those places removed as a result of closure.

Impact on the Community

13. A statement and supporting evidence about the impact on the community and any measures proposed to mitigate any adverse impact.

There are no foreseen community impacts resulting from the closure. The linked agerange extension proposed for Fairfield Infant School will ensure there is no change in the number of Key Stage 2 places available in the town. Parents will have additional certainty that a place is available for their children through the primary age range once a Reception place is secured, and children will benefit from guaranteed continuity.

In reality, children, parents and staff would see very little difference between how the two schools currently work and how a single school would work in the future. The county council is not proposing to build a new school; instead the two existing schools' buildings will continue to be used, only with a single Headteacher and single governing body rather than two of each.

Children who currently have places at the Junior School in Years 3-5 will all be guaranteed a place in the 'replacement' primary school, and there should be no disruption to their education.

14. Details of extended services the school offered and what it is proposed for these services once the school has discontinued.

The extended services available at Fairfield Junior School are after school clubs. These after school clubs will still be available at Fairfield Primary School, which will cater for the

displaced pupils.

Travel

15. Details of the length and journeys to alternative provision.

0 miles. The schools are not changing location. Fairfield Infant and Junior schools are located next to each other and the new proposed Primary School will continue to use the same buildings.

16. The proposed arrangements for travel of displaced pupils to other schools including how they will help to work against increased car use.

As there will be no change of location of the school there will be no impact on travel arrangements. Provision of transport will continue to be in line with the Local Authority's home to school transport policy.

Fairfield Primary School will have a Travel Plan, which will set out a number of practical ways to reduce the number of car trips to school, to encourage more walking and cycling and to improve safety on the school journey.
